- The light at the end of the tunnel



I was born in Oklahoma in 1940 and moved to Fresno in 1945. I attended Walter Elementary School and graduated from Clovis High School in 1958. A year later, I married my high school sweetheart in June 1959. The following year we began our family, a daughter in 1960 and a son in 1962. We were married 27 years and had celebrated having our first two grandchildren before my husband died suddenly of a heart attack in 1986. My third grandchild was born in 1989.

After the death of my husband, my family and friends urged me to begin square dancing where I met Bill. We continued to square dance and were very involved in our club for about ten years. Bill and I have been together since 1988. We currently live in Clovis and love living in the country. Up until the last few years we had horses and went on trail rides.

I enjoy being a grandmother and just became a great-grandmother in February. I enjoy doing all crafts but especially scrap booking and making jewelry. When I retired in 2006, Bill built me my own craft room.

I was diagnosed with Parkinson variant about a year after I retired but now realize I showed symptoms of the disease several years earlier. The first symptom I recall was the difference in my handwriting. Shortly thereafter I noticed I was moving slower, having trouble picking things up, problems with my balance, and I began to stoop over. It took quite a few doctor visits and tests before I was accurately diagnosed.

The first time I heard about the Greater Fresno Parkinson Support Group was shortly after I was diagnosed, and I believe I was in denial. I was not ready to accept Parkinson's. About a year later, I went to the annual Parkinson's Walk in Visalia and heard about the Fresno meetings. At the first meeting I attended in July of this year, I learned about the San Joaquin Rehabilitation Parkinson's Classes. Previously I had gone through some balance classes at Kaiser but find that the classes at San Joaquin Rehab much more beneficial.

I have good days and bad days and just have to take what I get with this disease. The most recent change in my condition has been in my eyesight. I have always been an avid reader and now find it very difficult. My eyesight has become very blurry so this has become my recent challenge.

To finish on a positive note, I have always relied on my sense of humor to get me by in life and one of my Parkinson's symptoms has been uncontrollable laughter.



Computerized Dynamic Posturography (“CDP”) is a test performed on an Equitest® machine to assess balance challenges that may be caused by PD. It is usually performed by a physical therapist and takes about 45 minutes to complete.

GFPSG: The November 26 – December 23, 2009, Wells Fargo Bank Statement shows a Beginning Balance of \$727.62. LSVT® LOUD, an effective, intensive voice treatment for individuals with Parkinson's disease ("PD"), is now available through a new computer program. The LSVT® Companion (LSVTC) functions as a standalone computer program allowing individuals with PD to independently progress through an entire LSVT® LOUD session while automatically collecting data on key treatment variables including: sound pressure level (loudness), fundamental frequency (pitch), and duration. Studies found that outcomes, when half of the standard 16 treatment sessions were conducted independently at home, were comparable to previously published efficacy data when all LSVT® LOUD sessions were held face-to-face.
